Subject: Regularization of The Karnataka College of Nursing, Bangalore.

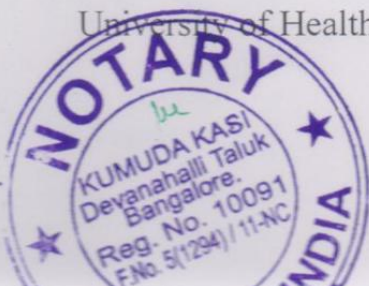
**Read:** Letter dated 14.08.2003 vide No. ACA:F:NS.95/2003-2004 of Rajiv Gandhi University of Health and Science, Bangalore.

### Preamble:

An application under Rule 45 of 1994 of the Rajiv Gandhi University of Health Science in respect of B.Sc., Nursing Course for the academic year 2003-04 was made by the The Karnataka College of Nursing, Bangalore. The Investigation of the college in consultation with the Enquiry Committees wherein it was discussed well at the Syndicate meeting after the perusal of all the document under Rule 45-1994 of the Rajiv Gandhi University of Health and Science, Bangalore was submitted to the Government.

**GOVT. ORDER NO. H&FWS 258 MPS 2003, BANGALORE, DATED 24.12.2003**

While exercising its power under Rule 45(5) of 1994, the Rajiv Gandhi University of Health Sciences has permitted The Karnataka College of Nursing,



Bangalore to admit B.Sc., Nursing Course with a limitation of 60 student for the year 2003-04 under the following terms and conditions and organize to make it effective from 2003-04 and recommends as under:

### TERMS AND CONDITIONS

1. Permission has to be obtained by Rajiv Gandhi University of Health Sciences to commence the course.
2. It is mandatory to obtain permission under the rule 13 of 1947 follow the rules and regulations laid by the Indian Nursing Council. Also must possess basic facilities The Karnataka Nursing Council and Indian Nursing Council as per the terms and conditions laid under the Rajiv Gandhi University of Health Sciences.
3. Admission of the students must be made only after regularization of the course under Rule 13 of 1947 by The Indian Nursing Council. no circumstances, there should not be any additional admission of the students of the course. In case of any violation of rules, the students are forbidden for the admission and the educational institution would be derecognized and criminal action would be initiated against the same.
4. Any order or direction of Indian Nursing Council, Karnataka State Nursing Council and state Government has to be strictly followed from time to time.
5. As per the direction of Indian Nursing Council is required to possess its own hospital within a period of 5 years, failing which the regularization would be withdrawn.
6. Admission and selection of the students during the year 2003 in Karnataka Nursing, Pharmacy and Physiotherapy, M.Sc. Nursing, M.T.P and MPharma courses must be strictly in accordance with the ratio of Government and Management quota.
