PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Subject: To regularize P.B.B.Sc., Nursing Course of The Karnataka College of Nursing, Bangalore.

Preamble:

Under the Rule 45(2) of 1994 The Rajiv Gandhi University of Health Sciences, with reference to the letter (1) and (2) mentioned above, has been thoroughly perused by Academic Council and the Syndicate, which has given its Committee's recommendation for The Karnataka College of Nursing, Bangalore to commence the P.C.B.Sc. Nursing Course with an annual 25% of limited seats to regularize the same to the Govt. of Karnataka.

After thoroughly perusing all the concerned documents, the Government has regularized The Karnataka College of Nursing, Bangalore to commence newly P.B.B.Sc. Nursing Course with an annual 60 limited seats under which the order has been passed by the Government.



**GOVT. ORDER NO. H&FWS 303 MPS 2010, BANGALORE, DATED
12.07.2010**

While exercising its power under Rule 45(5) of 1994, the Rajiv Gandhi University of Health Sciences has permitted The Karnataka College of Nursing, Bangalore to commence P.B.B.Sc. Nursing Courses for the academic year 2009-10 with a limitation of 60 seats annually under the following terms and conditions:

TERMS AND CONDITIONS

1. The Karnataka College of Nursing, Bangalore shall make way for 20% quota of seats to the Government for the distribution of same.
2. Sanction is necessary to commence the above nursing courses by the Rajiv Gandhi University of Health Sciences.
3. Confirmation must be taken by the Indian Nursing Council under Rule 13 of 1947 and it is compulsory to follow the rules and regulations and procedure laid out by the Indian Nursing Council. The basic amenities have to be provided under the prescribed rule of the Rajiv Gandhi University of Health Sciences.
4. Admission of the students must be made only after availing the permission by the Indian Nursing Council under the Rule 13 of 1947 of Indian Nursing Council. Under no circumstances the number of students shall be increased. In case of any violation of the same the institution would remain derecognized and admission of students remain prohibited under the Rule of 1991 and criminal proceedings will be initiated against the institution.
5. Any order or direction issued by Indian Nursing Council, Karnataka State Nursing Council and State Government has to be strictly adhered to from time to time.

6. As per the instructions of Indian Nursing Council, a Hospital must be owned with in 5 years of time, failing which the permission of the college would be withdrawn.
7. The admission and selection of the students during the year 2003 in Karnataka Nursing, Pharmacy and Physiotherapy, M.Sc. Nursing, M.T.P and M.Pharma courses must be strictly in accordance with the ratio mentioned above under the Government and Management quota.
8. The college will not be facilitated with any assistance or financial aid. The college remains permanently unaided under the terms and conditions.
9. If the college violates any of the terms and conditions mentioned above, the regulation would be withdrawn under the Rule 48 of 1994 of Rajiv Gandhi University of Health Sciences, Bangalore.
